This matter is before the Court upon the application and request by Wilhelm Bronander (the "Applicant") for exemption from the fees imposed by the Electronic Public Access Fee Schedule adopted by the Judicial Conference of the United States Courts.

The Court finds, based upon the attached letter received on April 6, 2017, that the Applicant has demonstrated that an exemption is necessary in order to avoid unreasonable burdens and to promote public access to information.

Accordingly, the Applicant shall be exempt from the payment of fees for access via PACER to the electronic case files maintained in this Court to the extent such use is incurred in connection with the project described in the attached letter and application. The Applicant shall not be exempt from the payment of fees incurred in connection with other uses of the PACER system in this Court.

Additionally, the following limitations apply:

- 1. This fee exemption applies only to the Applicant, and is valid only for the purposes stated above.
- 2. This fee exemption applies only to the electronic case files of this Court that are available through the PACER system;
- 3. By accepting this exemption, the Applicant agrees not to sell for profit any data obtained as a result of receiving this exemption.
- 4. This exemption is valid from April 1, 2017 through May 30, 2017.

Dear Judge Morris,

I, Wilhelm Bronander, am an MBA candidate at The Wharton School at the University of Pennsylvania. I am currently enrolled in Professor Wei Wang's bankruptcy and corporate reorganization course (FNCE 891: Corporate Restructuring) and am requesting a PACER fee waiver for the academic research required in my studies.

I believe that in accordance with the Judicial Conference Policy regarding Electronic Public Access Fees, you may exempt individual researchers associated with educational institutions to avoid unreasonable burdens and to promote public access to such information.

As a final project for my course, I am required to analyze a company currently undergoing a bankruptcy reorganization from the standpoint of an advisor or investor. For this purpose, I need information contained in several documents: petition filings, schedules, post-petition financing, disclosure statements, and plans of reorganization / liquidation. To conduct my research, I request access to court documents contained in the court docket for the bankruptcy filings contained in the Southern District of New York.

The total cost of obtaining such documents at the usual PACER fee of \$0.10 per page would be large. I estimate a total cost between \$500 and \$700, depending on the number of documents. As a student, I cannot afford to cover these out of pocket expenses and The Wharton School does not provide a budget for academic research in this course.

I request a fee waiver effective as soon as possible and ending on April 30<sup>th</sup>, 2017 to ensure adequate time for the completion of my research. I agree, following Judicial Conference Policy, that any data received through this exemption will not be used for commercial purposes, will not be transferred, and will not be redistributed online.
